

ENGAGEMENT LETTER FOR INDIVIDUAL TAX PREPARATION SERVICES

Tax Year

I am retaining Lottsa Tax & Accounting Services, Inc. (Lottsa) to prepare my 2024 individual income tax return from the information that I am providing.

I have carefully and completely gathered the information for my tax return. Those facts and materials are hereby forwarded to Lottsa.

- I believe that I am reporting all income subject to tax.
- I believe that all of my claims for deductions are valid and can be substantiated.
- I have qualified written acknowledgments for any charitable contributions \geq \$250 being claimed which include a statement similar to “no goods or services were provided in return for this donation”.
- I am aware that records and documents supporting claims of income and deductions must be retained.
- If applicable, I have contemporaneous daily records for self-employment vehicle use, travel, meals, and for the use of “listed property”.
- If total foreign holdings for which I am a signer were valued at \geq \$10,000 at any point during the tax year, I am providing information about those positions.
- We are reporting all cryptocurrency and Non-Fungible Tokens (NFT) holdings as of 12/31/2024 and all related transactions that occurred in 2024.
- I understand that LLC Compliance with the Corporate Transparency Act (“CTA”), including beneficial ownership information (“BOI”) reporting, is not within the scope of this engagement.
- I understand that, as paid preparer, Lottsa is not auditing our information. Lottsa does not attest to the completeness or accuracy of the information provided to Lottsa. That is my responsibility.
- I know that tax returns are subject to review by tax authorities. Lottsa is available to help if there is an inquiry or audit. I understand that additional fees apply for audit replies and representation.

I understand that **the tax return will be prepared for electronic filing with the IRS and any appropriate state tax authority.** Transmittal will not occur until I review the completed tax forms and return the **signed E-file Authorization Form to Lottsa.**

I understand that tax services will be provided at the firm’s hourly rates as stated on the company’s website. Further, I will pay the invoice promptly and in full upon completion of the tax preparation services.

If utilizing the Early Bird Discount, I understand that my Tax Organizer, Engagement Letter, and all of the tax materials that are in my power to produce must be turned in by February 10 to be eligible.

I understand that Lottsa will provide a copy of my final 2024 tax return(s) as a PDF through Lottsa’s secure Client Portal (Canopy) and that it will be my responsibility to download and save the file.

If I prefer a different method of delivery for my 2024 tax return(s), I will make the appropriate entry in the Tax Organizer Questionnaire.
